GUIDES FOR THE USE OF SHORT TERM CAMP FACILITIES

To be signed by all groups upon entering camp

- 1. Reservations to be filed at Council Service Center at least 10 days in advance of trip. Permission to use site available only by permit. Unit must be currently registered (not lapsed or dropped) to use camp facilities. Tour permits are required.
- 2. Unit must be under the registered leadership of 2 adults, one at least 21 years of age and one at least 18 years of age.
- 3. Check-In: On arrival, camping areas will be assigned by ranger or designee. Fees will be paid upon arrival at camp. All Out of Council units are to have a Tour Permit, signed and approved by their local council.
- 4. Firearms: no firearms or ammunition will be allowed in camp. No other weapon should be brought into camp, such as bows and arrows, slingshots, etc. Only council approved range masters may operate our rifle, shotgun and archery ranges.
- 5. Instruct everyone that red flags warn of rifle, shotgun and archery ranges. Use caution in these areas at all times they are in operation.
- 6. Areas around water tanks and water supply are prohibited; do not go into these areas.
- 7. <u>Fires</u>: All fires must conform to local regulations and be built in designated spots for cooking or campfires. See #10 also.
- 8. Campsites are provided with water and latrine facilities.
- 9. <u>ALL GARBAGE</u> is to be taken home with you.
- 10. <u>Fuel Supply</u>: Use down timber. DO NOT cut any green timber unless instructed to do so by the Camp Ranger. The use of all liquid fuels is to be under the strict control of adults and following guidelines by BSA policy. All extra fuel is to be kept locked at all times.
- 11. No flames are allowed in tents.
- 12. <u>First Aid</u>: Be prepared to handle all minor cases in your unit area. Any problems which cannot be handled by the unit should be immediately reported to the Camp Ranger.
- 13. Troops are to provide all equipment including tentage, bedding, cooking utensils, food and personal gear. No camp equipment is to be moved from one campsite to another without permission of the Camp Ranger.
- 14. <u>Parking</u>: Is restricted to designated areas, fire roads are NOT to be used by any vehicle other than official camp vehicles. **DO NOT drive in campgrounds**.
- 15. No washing of dishes near stand pipes and washstands.
- 16. <u>Camp Cleanliness</u>: Each unit is held responsible for the area in and around its own campsite as well as the personal cleanliness of the unit members.
- 17. Shoes: Must be worn at all times
- 18. **NO DOGS OR PETS IN CAMP** (except guide dogs for the disabled).
- 19. Stay within the boundaries. Everyone is to remain within the camp property.
- 20. <u>Our neighbors</u>: We enjoy good relations with our camp neighbors and ask units to observe Scout Courtesy not only to them but all persons while enroute to and from our camps.
- 21. <u>Transportation</u>: Transportation to and from the camp is the responsibility of the sponsoring institution and its unit committee to arrange. All vehicles should conform to Sate of California highway regulations, should be driven by licensed drivers 18 years of age or older and in vehicles carrying adequate insurance. **Under no circumstances are passengers to be carried in trucks, except in cab.**
- 22. <u>Check-Out</u>: All units must clear through the Camp Ranger prior to checking out at the close of their stay in camp.
- 23. ALCOHOLIC BEVERAGES and CONTROLLED SUBSTANCES are NOT PERMITTED on camp property.
- 24. <u>Use of buildings</u>, kitchen, dining hall, etc., is by permit only. Special rules and fees apply to their use. Reservations are to be made ahead of time at the Council Service Center.
- 25. <u>Swimming Pool</u>: An adult 21 years of age with Safe Swim Defense certification is in charge. Unit swims must have an individual with BSA Water Safety Instructor, Red Cross Lifeguard, BSA

Lifeguard or YMCA certification. District camporees, Webelorees, etc., will have an adult 21 years of age with one of the above certifications plus Safe Swim Defense.

- 26. NO fireworks are permitted in camp.
- 27. NO hazing or initiations.
- 28. SIBLING POLICY: Due to liability considerations and the lack of appropriate facilities, the San Francisco Bay Area Council must enforce the policy that only registered Scouts attend related functions at camp. Children/siblings of those registered for a specific program are not to attend unless the program has been specifically designed with adequate facilities to handle them.
- 29. The Camp Ranger has the authority on site to interpret and enforce these guides, local and national council policy and applicable state/local laws. Failure to follow the ranger's direction can lead to cancellation of use permit and expulsion from camp property.
